



## **Contractual Agreement for Scholarship Rate Athletes**

This agreement specifies the terms under which Illinois Eastern Community colleges and JBS Global LLC will conduct the business of enrolling International students in Illinois Eastern Community Colleges in the State of Illinois, United States of America.

1. Your agency will help in the advertising, marketing, and delivery of educational services provided by colleges of Illinois Eastern Community Colleges (the District) with headquarters in Olney, Illinois, U.S.A.
2. Your agencies efforts will be directed toward encouraging international students or potential students to enroll for full-time (12 or more credit hours) study at one of the colleges of the District, for academic credit or for English as a Second Language program. Payment for services will be contingent upon such enrollment and payment by the student to the college.
3. Payment to your agency will be at the rate of **20%** of tuition for the first year per full-time student status, paying the International Scholarship rate of \$150 per credit hour, payable immediately upon enrollment and payment of full fees by the student.
4. Immediately upon receipt of the completed student's application, the I-20 will be sent to your agency to assist the student in obtaining a student visa (F-1).
5. This contract is valid from November 15, 2022 through November 14, 2024, subject to renewal at expiration. Either party may terminate the agreement upon (30) days written notice.
6. Neither party is subject to liability beyond the terms specified in the contract.

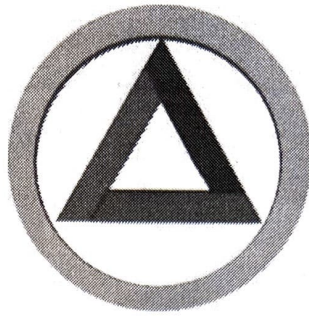

## Contractual Agreement for Recruitment of International Students

This agreement specifies the terms under which Illinois Eastern Community Colleges and JBS Global LLC will conduct the business of enrolling international students in Illinois Eastern Community Colleges in the State of Illinois, United States of America.

1. Your agency will help in the advertising, marketing, and delivery of educational services provided by colleges of Illinois Eastern Community Colleges (the District) with headquarters in Olney, Illinois, U.S.A.
2. Your agencies' efforts will be directed toward encouraging international students or potential students to enroll for full-time (12 or more credit hours) study at one of the colleges of the District, for academic credit or for English as a Second Language program. Payment for services will be contingent upon such enrollment and payment by the student to the college.
3. Payment to your agency will be at the rate of fifty percent **50%** of tuition for the first year of full-time student status, paying full tuition rate, payable immediately upon enrollment and payment of full fees by the student.
4. Immediately upon receipt of the student's completed application, and receipt of all required documentation, the I-20 will be sent to your agency to assist the student in obtaining a student visa (F-1).
5. This contract is valid from November 15, 2022 through November 14, 2024, subject to renewal at expiration. Either party may terminate the agreement upon (30) days written notice.
6. Neither party is subject to liability beyond the terms specified in the contract.
